**SPECTRUM CLASS COUNSEL’S MOTION FOR AN AWARD OF ATTORNEYS’ FEES**

Spectrum Class Counsel, Bernstein Litowitz Berger & Grossmann LLP and Stafford Rosenbaum LLP, in accordance with Federal Rules of Civil Procedure 23(e) and 23(h) and this Court’s Order Preliminarily Approving Settlement and Authorizing Dissemination of Notice of Settlement, dated November 17, 2021 (dkt. 102), will and do hereby move this Court, before the Honorable James D.
